**HOME STUDY FEES**

**PLACEMENT FEES**

**Placement Fee for Healthy Infants (includes Post –Placement Supervision Fee) see income fee schedule below.** This includes healthy infants of any racial or ethnic background. Placement fee is due in full at the time of placement. A federal tax credit is available to adoptive parents of healthy infants. Consult your tax advisor.

**Income Fee Schedule**

- Less than \$83,000 annually \$15,000
- Over \$83,000 Annually 18% of annual income (maximum fee of \$18,000)

**Placement Fee for Special Needs Children (includes Post –Placement Supervision Fee) \$7,000 \***  
This includes some children with long term medical issues; school age children; sibling groups (healthy newborns excluded); and other identified children with special placement needs A federal tax credit is available to adoptive parents of children with special needs. Consult your tax advisor.

**\* Up to \$4,000 in pre-birth expenses will be in addition to the Placement Fee**
